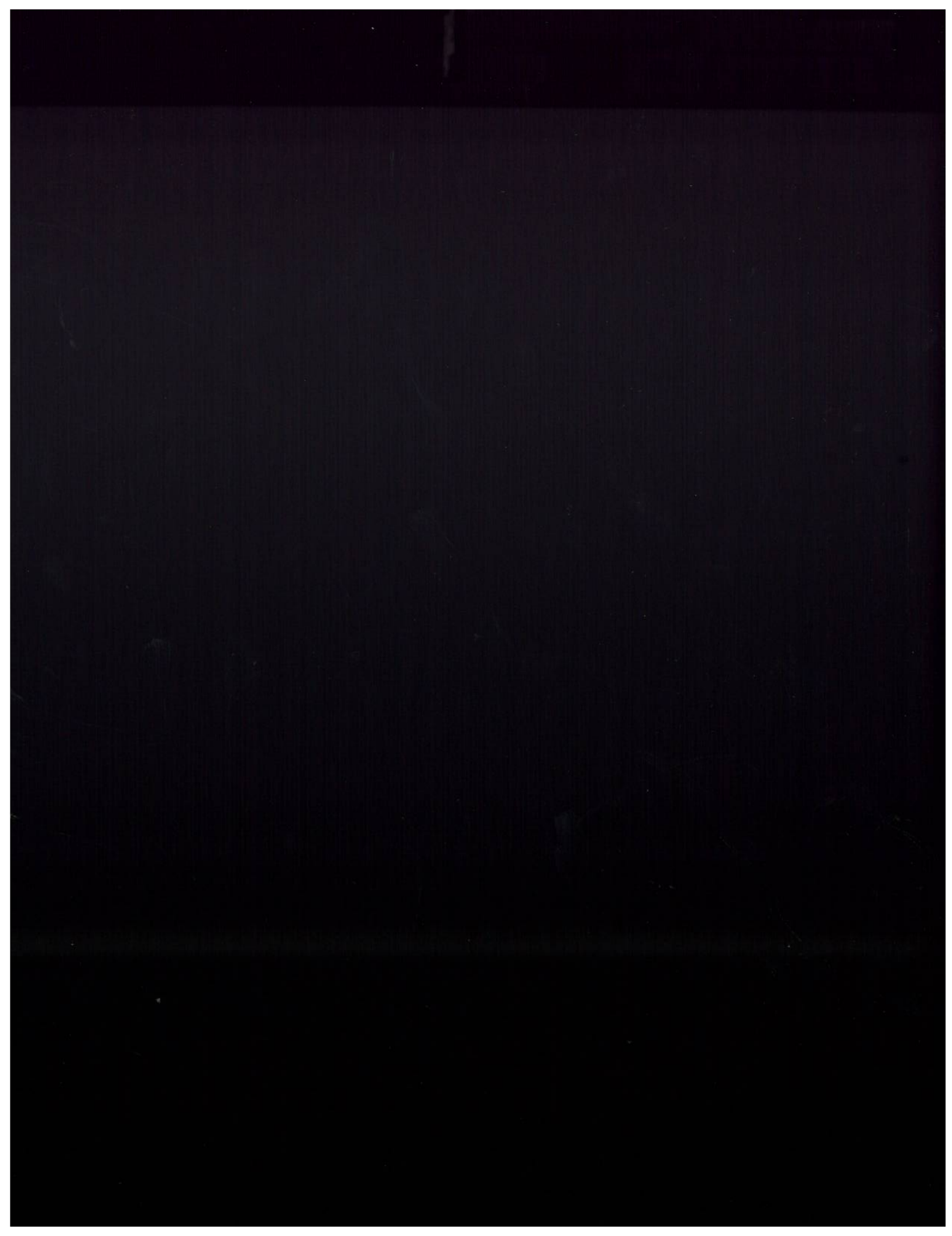


CROSS COUNTRY EMMAUS BOARD MEETING
